ORDER

This Writ Petition has been filed in the nature of a Mandamus seeking to examine the representation given by the petitioner on 12.11.2024. It is also contended that the spelling of the name of the petitioner differs in the certificate and as given before the respondents.

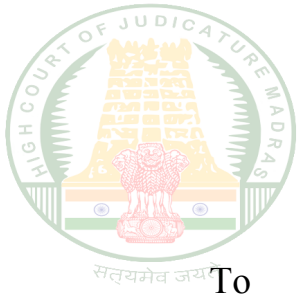
