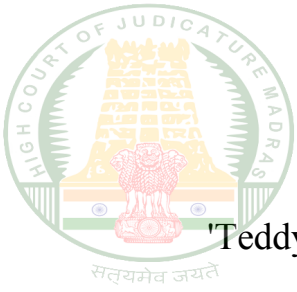

According to the petitioner, he is establishing a business of running Massage parlour, SPA, Beauty Parlour in the name and style of "Teddy Wellness Hairstyle's Salon and Spa at No.4, 524, MRP Complex,, I Floor, Veerapandi (post), Pallaam, Tiruppur 641 605. Seeking no objection certificate to run the abovesaid business in the above address, he gave a representation to the respondents on 28.01.2025. However, the respondents have not issued any no objection certificate and also kept the representation of the petitioner dated 28.01.2025 pending till date without passing any orders. Hence, the petitioner has come forward with the present writ petition seeking the abovsaid relief

3. Heard the learned counsel for the petitioner and the learned Govt. Advocate (crl.side), appearing for the respondents.
