This Criminal Original Petition has been filed to quash the C.C. No.1038 of 2021 on the file of the XVII Metropolitan Magistrate, Saidapet, thereby taken cognizance for the offences under Sections 294(b), 324 and 506(2) of IPC.

2. Pending this petition, the parties have decided to bury their hatchet and compromise the dispute amicably among themselves.

3. A Joint Memo of Compromise has been filed before this Court, which has been signed by the petitioners and the defacto complainant and also by their respective counsel. All the parties are present and identified by their respective counsel and the Police. 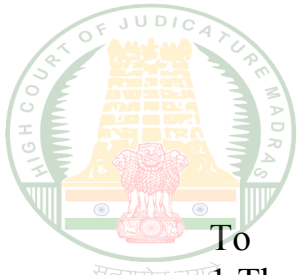
4. Under such circumstances, no useful purpose will be served in keeping the proceeding pending, even though, the offences involved are not compoundable in nature. In the light of the guidelines given by the Hon'ble Supreme Court reported in **2017 9 SCC 641-(Parbathbhai Aahir @ Parbathbhai Vs. State of Gujrath)**, this Court in exercise of its jurisdiction under Section 528 of BNSS, 2023, quashes the proceeding in C.C. No.1038 of 2021 pending trial on the file of the XVII Metropolitan Magistrate, Saidapet

5. In view of the above, the proceedings in C.C. No.1038 of 2021 on the file of the XVII Metropolitan Magistrate, Saidapet, is hereby quashed as against the petitioners. The terms of Joint Memo of Compromise shall form part and parcel of this Order.

6. Accordingly, the Criminal Original Petition stands allowed.
