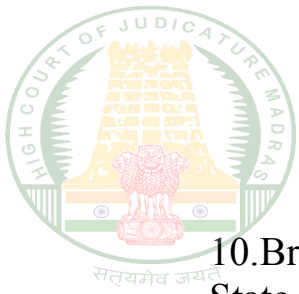

3. In these circumstances, the petition seeking an early disposal cannot be entertained at this juncture. The civil revision petition is dismissed. No costs.

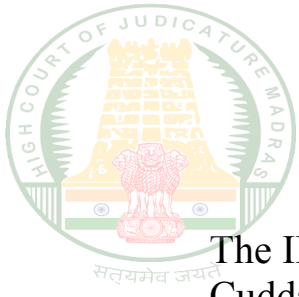
