ORDER

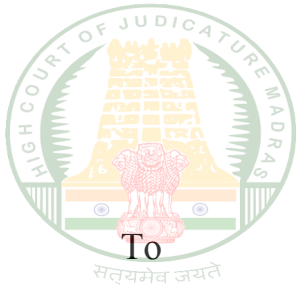
Learned counsel for the petitioner sought permission of this Court to withdraw this writ petition. Permission is granted.
