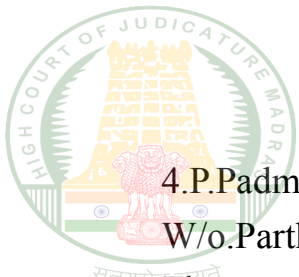

and Mr.A.Selvendran, learned Special Government Pleader for respondents 1 to

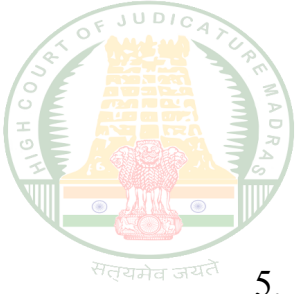
