Mandamus, to call for entire records pertaining to the impugned order dated

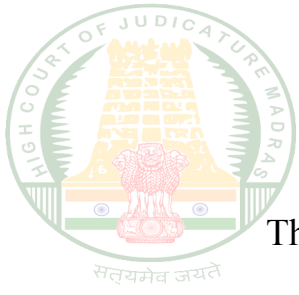
