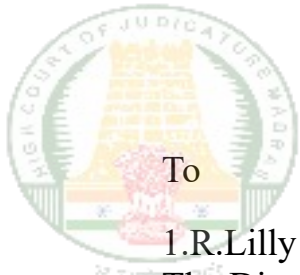
2. When the Division Bench has taken cognizance of the matter and has also granted the interim stay, it would not be appropriate to adjudicate this Contempt Petition in parallel.
