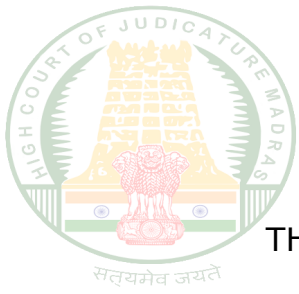

3.Recording the submission made by the learned counsel appearing for the petitioner, this writ petition is closed. No costs. Consequently, connected miscellaneous petition is closed.

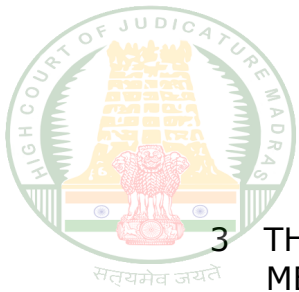

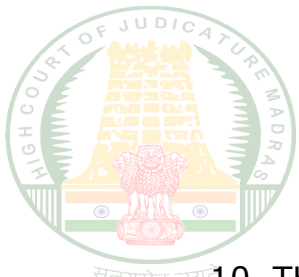
