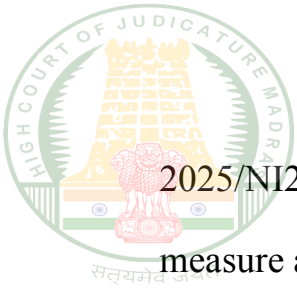

PRAYER

2. Heard Mr.S.Dheenadhayan, learned counsel for the petitioner and Mr.P.Murugan Raja, learned counsel for respondents.



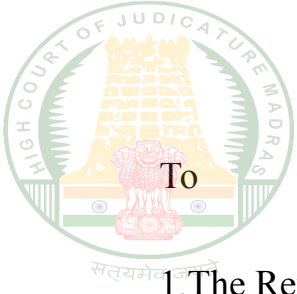

4. Taking into consideration the facts and circumstances of the case and the materials placed before this Court, there shall be a direction to the respondents 2 and 3 to act upon the application submitted by the petitioner on 25.01.2025 and conduct the survey in the subject property based on the title document. If there are any rival claimants, such survey shall be conducted in their presence. This process shall be completed by the respondents within a period of six weeks from the date of receipt of a copy of this order.

5. This writ petition is disposed of with the above directions. No costs.
