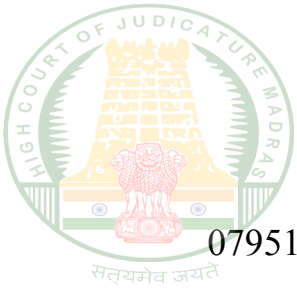

2. The case of the petitioner is that the petitioner established the solar power plant. In the course of the establishment, a refundable security deposit was provided. Once the work was completed and the plant was commissioned, the amount has to be refunded.

3. When the matter came up for hearing, the learned counsel for the both sides would submit the matter is no longer *res integra* and this Court can order the refund of the security deposit.
