2. Heard Mr.Shangar Murali, learned counsel for the petitioner, Mr.Mr.R.Gokulkrishnan, learned Additional Government Pleader appearing for respondents 1 and 2 and Mr.V.J.Priyadarsana, learned Government Advocate [Crl.side] appearing for respondents 3 and 4.

3. When the matter was taken up for hearing today, learned Government Advocate appearing on behalf of the respondents 3 and 4 submitted that the complaint given by the petitioner was enquired and it

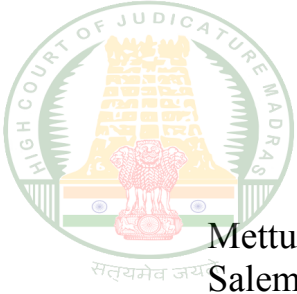
