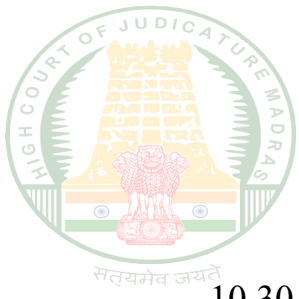

Crl.M.P.No.16782 of 2024 in Crl.O.P.No.24825 of 2024 dated 29.11.2024.

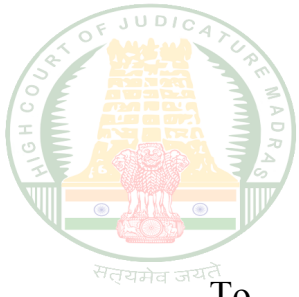
2. Learned Government Advocate (Crl.Side) for the respondent police
