2. Heard both sides.

3. This Court is of the view that the condition can be modified as follows:

6(c). The petitioner shall report before the respondent police daily at 10.30 a.m, for a period of three days and thereafter as and when required for the interrogation.”

The other conditions imposed in the order dated 22.01.2025 in Crl.O.P. No.892 of 2025 shall remain unaltered.

4. Further, time to furnish surety is extended by a period of two weeks
