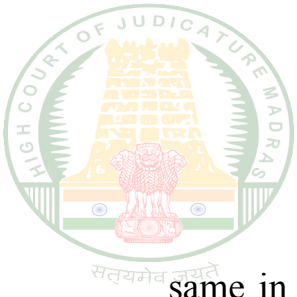
ORDER

However, in view of the nature of the order that is proposed to be passed, time is not given and notice is also not ordered to the respondents 2 and 3 and the Writ Petition is disposed of at the admission stage itself on the following terms:-

(i) The 1st respondent - Insurance Regulatory and Development Authority of India shall take up the representation of the petitioners dated 28.12.2024 for enquiry and after due issue of notice to the respondents 2 and 3, consider the
