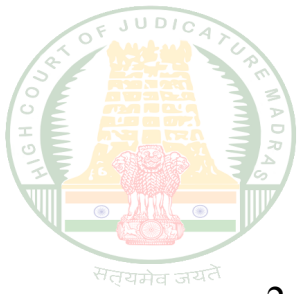

(i) The petitioner is a resident of Chennai where she is living with her child in her parents' home.

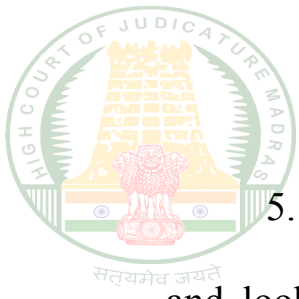
(ii) She is depending on her parents even to meet her day-to-day expenses.

(iv) She has to travel nearly 50 kms up and down from Chennai to Thiruvallur for every hearing along with her child which is very difficult for her.

(v) The respondent- husband is not paying any maintenance to her.
