3. In view of the aforesaid letter dated 21.04.2025, this contempt petition is closed.

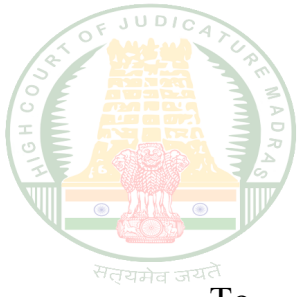
