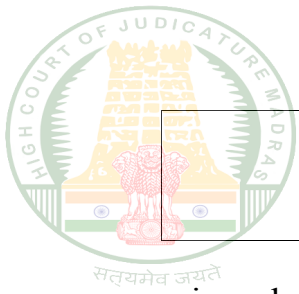

2. Hence, this Writ Petition is closed as having become infructuous. No costs.

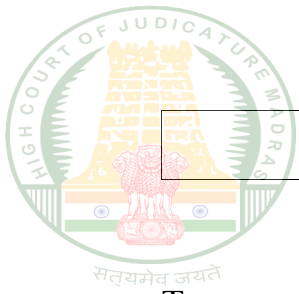

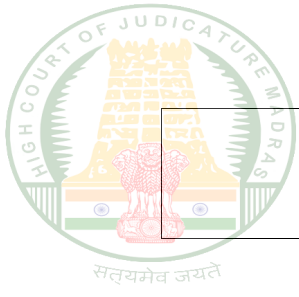
