PRAYER: Petition filed under Article 226 of the Constitution of India to issue a writ of Habeas Corpus, calling for the records relating to the detention order passed by the 2nd respondent in his proceedings bearing No.38/BCDFGISSSV/2025 dated 28.01.2025 under Tamilnadu Prevention of Dangerous Activities of Boot-leggers, Cyber Law offenders, Drug Offenders, Forest Offenders, Goonda, Immoral Traffic Offenders, Sand Offenders, Sexual Offenders, Slum Grabbers and Video Pirates Act, 1982 (Tamil Nadu Act 14) and quash the same and direct the respondent to produce the detainee, Munusamy, son of Marimuthu, now confined in Central Puzhal Prison, Chennai before this court and set the detainee, Munusamy, son of Marimuthu at liberty.
