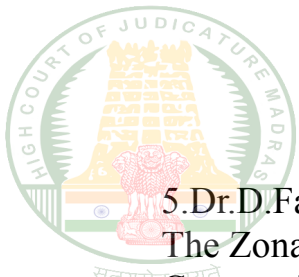

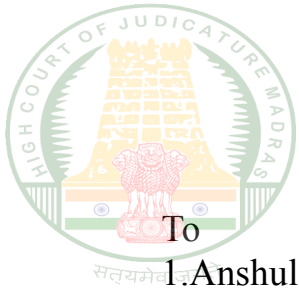
2. Recording the submission made by the learned counsel for the petitioner, this contempt petition is closed.
