ORDER

This Writ Petition is filed for a prayer calling for the records on the file of the 2nd respondent dated 10.02.2025 and to quash the same and consequently forbear the 2nd respondent from in any manner interfering with or disturbing the petitioner from continuing his life membership No.341.

2. The impugned order is passed by the 2nd respondent which is a society registered under the Tamil Nadu Registration Act, 1908. Therefore, it is a private organisation and it is also not exercising any public duty exercisable by the State.

3. In view thereof, the Writ Petition against a private person is not maintainable. Keeping open the liberty of the petitioner to approach the

appropriate forum, this Writ Petition stands dismissed as not maintainable.
