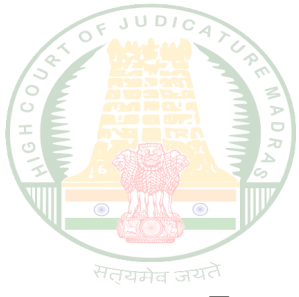
4. On the aforesaid terms, the present petition stands ordered.
