ORDER

The petitioner seeks modification of condition 4(b) imposed on the petitioner in Crl.O.P.No.2102 of 2025 dated 29.01.2025.

2. The learned Government Advocate (Crl.Side) submitted that the petitioner has complied with the conditions only for twenty days.

3. In response, the learned counsel for the petitioner submitted that since he has business at Palladam, Tiruppur, he is unable to stay at Chennai and report before the Inspector of Police, B-1, North Beach Police Station.

4. Considering the aforesaid facts, this Court is of the view that the condition 4(b) imposed on the petitioner in Crl.O.P.No.2102 of 2025 dated 29.01.2025 can be modified, directing the petitioner to appear before the respondent police for a period of one week and thereafter, before the
