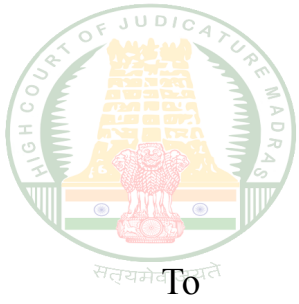

A perusal of the order dated 13.03.2023 passed by the Judicial Magistrate, Tiruvarur in Crl.M.P.No.1695 of 2023 reveals that the second respondent was directed to conduct preliminary enquiry and if necessary, register the FIR and file a report on or before 04.05.2023. As directed by the Judicial Magistrate, Tiruvarur, the second respondent conducted a preliminary enquiry and submitted a report on 05.08.2023 and closed the complaint as civil in nature.

4. In view of the above, the prayer sought for in this petition cannot be considered. Accordingly, this Criminal Original Petition stands dismissed.
