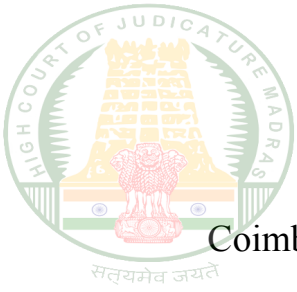

Taking into consideration the facts and circumstances of the case and considering the materials placed before this Court, there shall be a direction to the first respondent to deal with the revision petition filed by the petitioner on 01.11.2022 on its own merits and in accordance with law, after affording opportunity to respondents 4 to 6 and final orders shall be passed within a period of eight weeks from the date of receipt of a copy of this order.
