2. Heard the learned counsel for the petitioner and the learned Public Prosecutor (Pondy) for the first respondent and perused the materials placed on record.

The Chief Judicial Magistrate at Puducherry in Crl.MP.No.743 of 2024, directed to transfer a sum of Rs.9,65,073/- (Rupees nine lakh sixty five thousand and seventy three only) to the account of the petitioner. Thereafter, the first respondent also requested the second respondent to comply with the order. However, so far, the second respondent did not comply with the same and it is pending.
