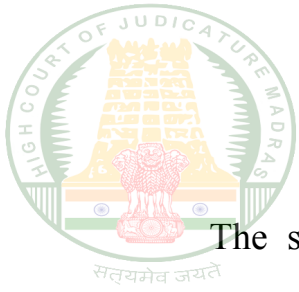
“(xi) against the entry “15. Office Assistant” in column (1),-
