Prayer: This Writ Petition is filed under Article 226 of Constitution of India seeking Writ of Certiorarified Mandamus to call for the records relating to the impugned proceedings of the 3rd respondent in his office Ref.O.Mu.No.31254/Vu.O.O.Sa.(1)/2015 dated 29.12.2015, quash the same and direct the respondents 2, 3 & 5 to count the petitioner's qualifying service rendered by him in the Medical Service Department, Government of Tamilnadu (4 years, 10 months and 10 days) for grant of pension to the petitioner, re-fix the petitioner's pension and pay the arrears of pension and other connected benefits to the petitioner within the time frame.
