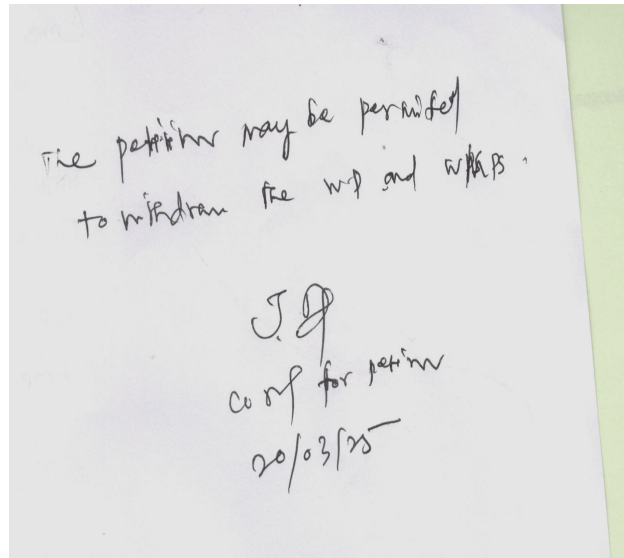

After some arguments, Mr.J.Pradeep, learned counsel on record for writ petitioner sought leave of this Court to withdraw captioned main 'Writ Petition' (hereinafter 'WP' for the sake of brevity) and 'Writ Miscellaneous Petitions' (hereinafter 'WMPs' for the sake of brevity) thereat but made a plea to preserve all the rights and contentions of the writ petitioner to prefer a statutory appeal under Section 10 of 'The Tamil Nadu Land Encroachment Act, 1905 (Tamil Nadu Act III of 1905)' {hereinafter 'said 1905 Act' for the sake of brevity}.
