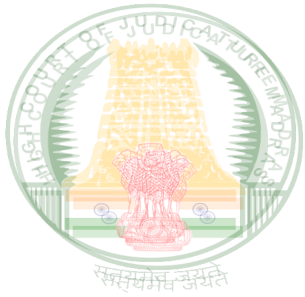
Accordingly, this Criminal Original Petition is dismissed.
