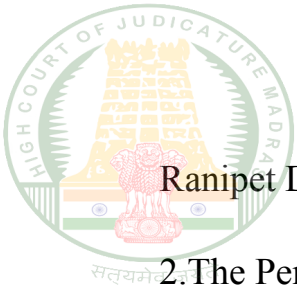

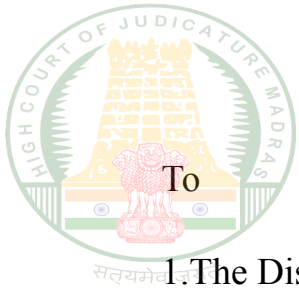
2.In view of the above submission, this Writ Petition is dismissed as withdrawn. No costs. Consequently connected miscellaneous petitions are closed.
