arose within the jurisdiction of this Court.

3.Upon considering the above submissions and examining the draft plaint and the affidavit

filed in support of this Application and considering the fact that the first and second

defendants are functioning within the jurisdiction of this Court, the cause of action for this

suit has arisen partly within the jurisdiction of this Court. Consequently, A.No.872 of 2025 is

allowed by granting leave to the applicant to sue the third respondent/ defendant before this

Court. As a corollary, the Registry is directed to number the suit, if it is otherwise in order.
