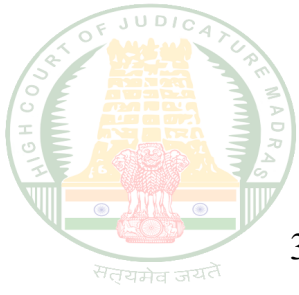

The learned counsel for the petitioner submitted that this Court by order dated 27.01.2015, passed an order in Crl.O.P.No.30704 of 2024 to transfer the case in M.C.No.49 of 2023 from Alandur Mahila Court to the Judicial Magistrate No.1, Krishnagiri.
