2. Heard Mr.R.Chandrasekaran, learned counsel for the petitioner and Mr.S.Jayachandran, learned Government Advocate appearing for respondents.

3. The petitioner is claiming right and title over the subject property through a registered sale deed dated 22.02.2023. Thereafter, there was some mistake in the T.Survey number and accordingly, the same was corrected as T.S.No.80/3. Thereafter, the petitioner was seeking for issuance of patta with respect to the subject property. Since the same was not considered, the present writ petition has been filed
