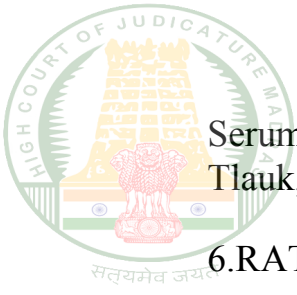

respondent herein.

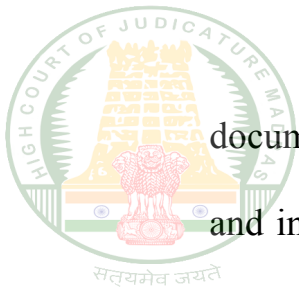

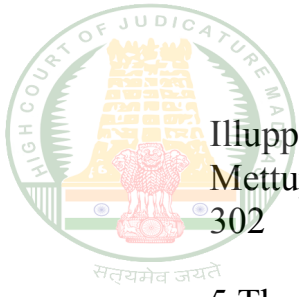

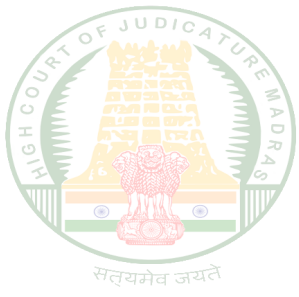
