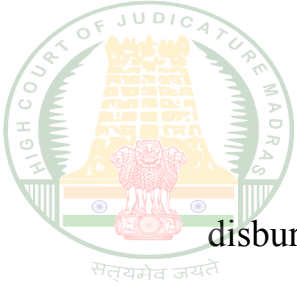

ORDER

This Writ Petition has been filed in the nature of a Mandamus seeking directions to the respondents to disburse the Provident Fund, Gratuity, Leave Encashment (Earned Leave and Old medical Leave), Leave Surrender for years 2009 - 2011 and 2017 – 2018 and 10 days salary and all other retirement benefits pending to the petitioner. Petitioner also seeks interest to be paid on the said amount.
