4. Taking into consideration the facts and circumstances of the case and the materials placed before this Court, there shall be a direction to the 2nd respondent to register the certified copy of the decree dated 04.03.2021 passed



in OS No.7107 of 2019 on the file of the XVI Assistant City Civil Court,
Chennai, forthwith.
