2. The representation dated 18.2.2025 itself has been posted only on 20.2.2025. Therefore, in our view, this is nothing but an attempt to force the authorities.

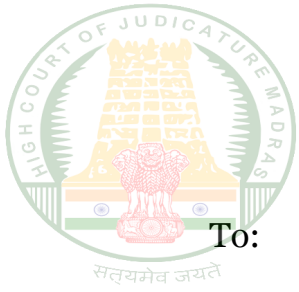
Petition is dismissed. There shall be no order as to costs. Consequently, interim application stands closed.
