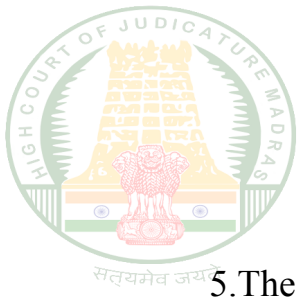

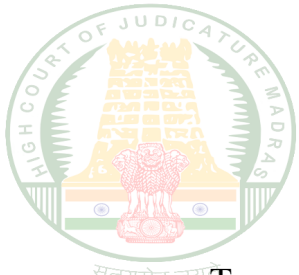
3.The learned counsel for the petitioner states that the petitioner was acquitted of all charges during the criminal trial. Subsequently, departmental proceedings were initiated and it is contended that the charges have been dropped. The petitioner now claims that he should be promoted from Junior Assistant to Assistant and be paid all the requisite allowances and monetary benefits. He further claims that a proposal in this regard was forwarded by the District Collector on 19.04.2023

4.A direction is issued to the respondents to examine the Service Register of the petitioner and determine whether the petitioner is entitled to be promoted to the post of Assistant and take a decision within a period of three months from the date of receipt of a copy of this order.

5.The Writ Petition stands disposed of. No costs.
