3. Reasons for seeking the transfer are as follows:-

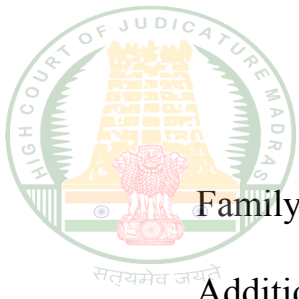
(i) The petitioner and her child are totally depending upon her parents for her day to day needs as the respondent/husband has failed to maintain her.
