No.4[b], in Crl.O.P.No.1978 of 2025 dated 29.01.2025.



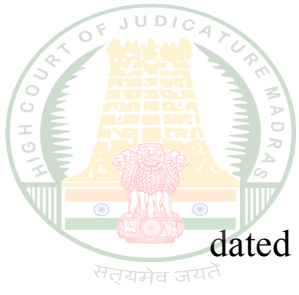

In view of the aforesaid submissions, the condition imposed on the petitioner in para No.4[b], in Crl.O.P.No.1978 of 2025 dated 29.01.2025 directing that the petitioner has to appear daily is modified, directing the petitioner to appear before the respondent police once in a week, viz., Saturday, at 10:30 a.m., until further orders.
