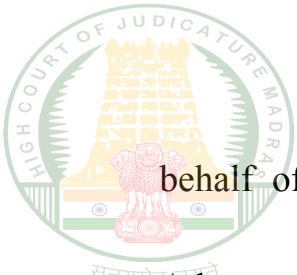

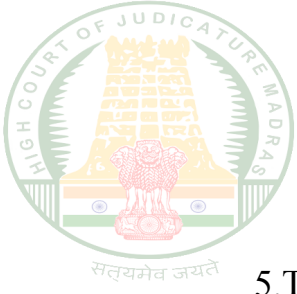
behalf of respondents 1 to 3 and Mr.V.J.Priyadarsana, learned Government

3.The petitioner is claiming right and title over the subject property through a registered Sale Deed dated 20.01.2025 The petitioner submitted an application on 10.02.2025 seeking for the survey of the subject property and necessary charges were also paid. Since the same was not acted upon, the present writ petition has been filed before this Court.

4.Taking into consideration the facts and circumstances of the case and the materials placed before this Court, there shall be a direction to the 2nd and 3rd respondents to act upon the application submitted by the petitioner on 10.02.2025 and conduct the survey in the subject property based on the title document. If there are any rival claims, the survey shall be conducted in their presence and if the situation warrants, the 4th respondent shall provide police protection.
