of Mandamus directing the respondents 4 and 5 to consider the petitioner grievance petition representation dated 16.11.2024 within a stipulated time fixed by this Court.

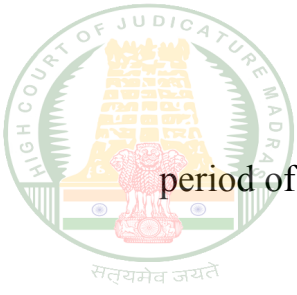
