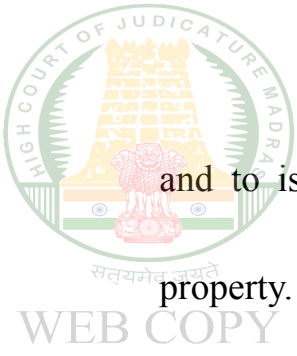

the 4th respondent to deal with the online application submitted by the petitioner



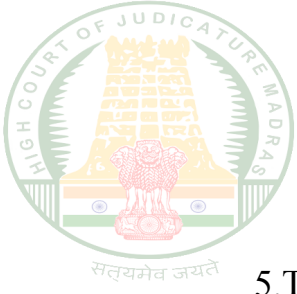
and to issue patta in the name of the petitioner with respect to the subject property.
