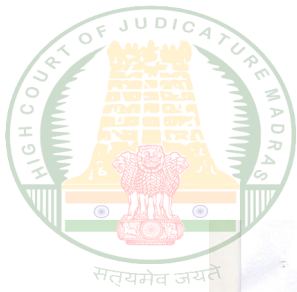

When the matter was taken up today, producing a joint memorandum of compromise dated 22.9.2025, duly signed by the plaintiff, the contesting first defendant and the fourth defendant, a plea was made on their behalf for recording of the same and decreeing of the suit in terms thereof.

2. While the plaintiff, R.Purushothaman and the first defendant, R.Senthil Kumar had been present in open court, having been identified by their respective counsel, Mr.A.Chidambaram and Mr.P.K.Srinivasan respectively, it is seen that defendants 2 and 3 were already set ex parte. The authorised signatory of the fourth defendant viz., B.Vijayganesh Kumar, who was also present in court, had been identified by the learned counsel viz., Ms.Indira Priyadharshini.

THE 1ST DEFENDANT**

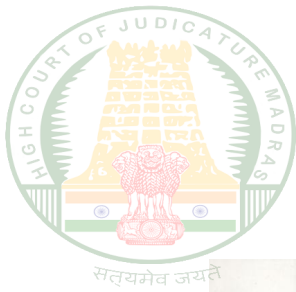
The Plaintiff and the 1st Defendant jointly beg to submit the following Compromise Memo:-

1. As per the mutual agreement and understanding arrived at among themselves, the 1st Defendant had agreed to pay a total sum of Rs. 1,85,00,000/- (Rupees One Crore and Eighty Five Lakhs Only) in full and final settlement of the suit claim and the Plaintiff had also agreed to for the same on the following terms and conditions.
2. The 1st Defendant had on this day paid a sum of Rs. 85,00,000/- (Rupees Eighty Five Lakhs Only) by way of Three Bankers Pay orders all drawn on Indian Overseas Bank Teynampet Branch, as detailed below.

- i) Pay Order No.157362315 for Rs.40,00,000/- (Forty Lakhs Only),
- ii) Pay Order No.157362322 for Rs.40,00,000/- (Forty Lakhs Only), and
- iii) Pay Order No.157362315 for Rs.5,00,000/- (Five Lakhs Only),

All the Pay Orders are issued in the name of the Plaintiff (R.Purushothaman). The Plaintiff hereby Acknowledges the receipt of the said total amount of Rs. 85,00,000/- (Rupees Eighty Five Lakhs Only) .

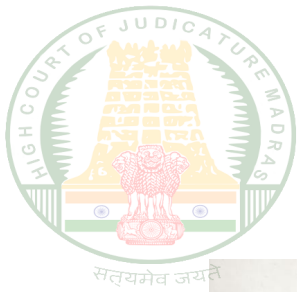
3. It is made clear that the above said sum of Rs. 85,00,000/- (Rupees Eighty Five Lakhs Only) had been made by the 4th Defendant M/s Revanza Global Ventures private. Limited to the Plaintiff this day for and on behalf of the Ist Defendant in pursuance of separate loan arrangement among themselves is accepted by the Plaintiff on the specific agreement and understanding that the 4th Defendant shall not at anytime in the future raise any claims whatsoever against the Plaintiff in this regard.
4. It is also acknowledged that the Plaintiff has irrevocably given up and relinquished all claims, rights title and interest past, present and future in respect of the movie and against M/s Revanza Global Ventures Private Limited, the 4th Defendant herein.
5. The balance of Rs.1,00,00,000/- (Rupees One Crore Only) shall be payable by the Ist Defendant to the Plaintiff in two installments Viz.
1. Rs. 50,00,000/- (Rupees Fifty Lakhs Only) within a period of Nine (9) months from this date i.e. on or before 21.06.2026 and the balance of Rs. 50,00,000/- (Rupees Fifty Lakhs Only) shall be paid within a period of Nine (9) months therefrom i.e. on or before 20.03.2027.
6. The Ist Defendant had also this day issued two post-dated Cheques bearing Nos.000344 dated 21.06.2026 and 000355 dated 20.03.2027 for Rs.50,00,000/- each both the Cheques drawn on HDFC Bank, Meyyanur Branch in favour of the Plaintiff and agrees to honour the said Cheques on the due dates without fail. However it is agreed that these amounts may alternatively be paid in cash, in which event of the correspondingly returned.

7. It is acknowledged that the remaining Rs. 1 Crore is solely the personal liability of the Ist Defendant and any non-payment by him will not create any claim or liability on M/s Revanza Global Ventures Private Limited, the 4th Defendant herein.
8. It is mutually agreed to among the Ist Defendant and the Plaintiff that the above said payment schedule shall be adhered to strictly and in case of default in payment of first instalment, the Plaintiff would be entitled to claim the entire sum of Rs 1,00,00,000/- (Rupees One Crore Only) forthwith together with interest at the rate of 24%p.a. from this date hereof till date of realisation.
9. There will be no orders as to costs of the suit.
10. Refund of full court fees paid on the Plaint may be ordered to be refunded to the Plaintiff.
11. It is made clear that in view of the above compromise there will be no claims against each other in future in any manner whatsoever.

Therefore the Plaintiff and the Ist Defendant jointly pray that the above joint Compromise Memo may be recorded and the suit may be decreed in terms thereof and refund of full Court Fees paid on the plaint may be ordered to be refunded to the Plaintiff.

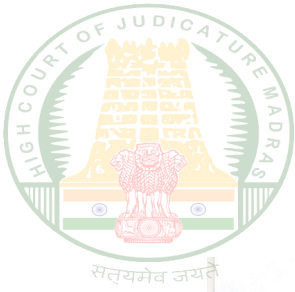

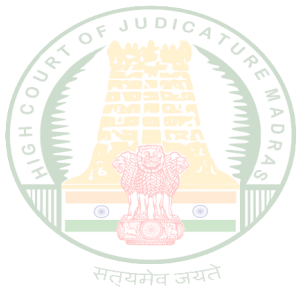
