ORDER

This writ petition has been filed challenging the impugned refusal Check Slip issued by the 1st respondent dated 18.02.2025 and for a consequential direction to the 1st respondent to register the Sale Deed.

2.Heard Mr.C.R.Gopinaath, learned counsel appearing on behalf of the petitioner and Mr.U.Baranidharan, learned Special Government Pleader appearing on behalf of the 1st respondent and Mr.N.R.Arun Natarajan, learned Special Government Pleader appearing on behalf of the 2nd respondent.

3.The refusal Check Slip has been issued by the 1st respondent based on the objections raised by the 2nd respondent to the effect that the property belongs

to the temple.



4. In the considered view of this Court, the 1st respondent can resort to the guidelines issued by the Division Bench of this Court in ***Sudha Ravi Kumar and another vs. The Special Commissioner and Commissioner, Hindu Religious and Charitable Endowments Department, Chennai and others*** reported in ***2017 3 CTC 135*** (Paragraph No.26).

5. Accordingly, a summary enquiry can be conducted and a decision shall be taken by the 1st respondent, within a period of four weeks with respect to the registration of the document presented by the petitioner, after hearing the petitioner and the 2nd respondent.

6. This writ petition is disposed of with the above directions. No Costs.

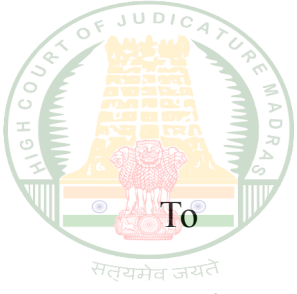
