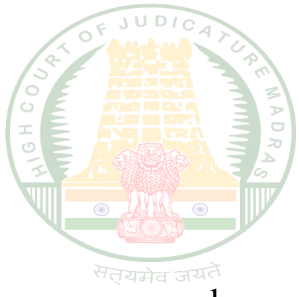
**ORDER**

This petition is filed to permit the petitioner to travel to Dubai as per the condition imposed in para 7(c) by order dated 04.10.2024 in Crl.O.P.No.20637 of 2024.

2. The learned counsel for the petitioner submitted that this Court *vide* order dated 03.03.2025 in Crl.O.P.No.5926 of 2024 has granted permission to the petitioner to travel abroad in another case subject to the following conditions:

*“5. The petitioner is directed to file undertaking affidavit before the respondent with particulars such as date of visiting abroad, the country's name, staying address in abroad and the reason for visiting abroad and date of return from abroad to India. On filing undertaking affidavit before the respondent, the petitioner is permitted to visit abroad.”*

3. Heard both sides.



4. This Court is of the view that the petitioner can be permitted to leave abroad. However, the petitioner shall furnish the details of stay at Dubai, date of departure and arrival before the trial Court, by way of an Affidavit, before leaving the country.

5. Accordingly, the criminal miscellaneous petition is ordered.
