2. The counsel on record for the petitioner has already filed a memo stating that he has given change of Vakalat and the bundle has also been returned back to the client.

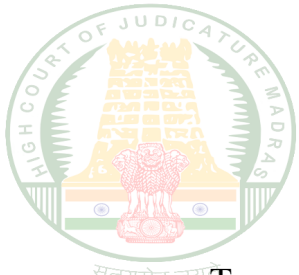
