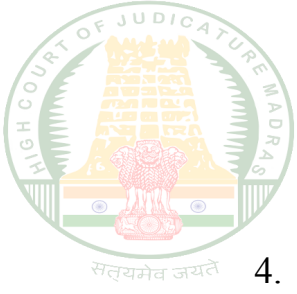

ORDER

This writ petition has been filed to issue a Writ of Mandamus to direct the respondents to pay interest @ 10% for the belated payment of Gratuity, P.F.Leave Salary and commutation of pension amount to the petitioners.

2. In the affidavit filed in support of the writ petition, it had been contended that the first and second petitioners have retired from service on attaining the age of superannuation on 30.04.2023 from the respondents. It is contended that Gratuity, Provident Fund, Leave Salary and Commutation of pension amount were disbursed only on 12.02.2025 for both the petitioners.

3. A direction is issued to the respondents that since it is a delayed payment, they should also pay interest @ 6% p.a. from the date of retirement till the date of actual disbursement. Necessary orders shall be passed within a period of three months from the date of receipt of a copy of this order.
