ORDER

This Writ Petition has been filed in the nature of a Mandamus seeking a direction against the respondents to pay the difference amount of what was paid and what the petitioners claim should have been paid with respect to gratuity, leave salary and if the petitioner is entitled, to pay the same with interest. The petitioners also seek 10/11 days of salary which also to be paid to the petitioners. The petitioners further seek interest for the delayed payment of terminal benefits like gratuity and leave salary.

2. Heard the learned counsel for the respondents.

3. The respondents may examine the service records of the petitioners and examine the eligible amounts which are due and payable to the petitioners. If the petitioners are eligible for any payment, disburse the same within a period of three months from the date of receipt of a copy of this order with interest at the rate of 6% per annum from the date of retirement till the date of actual disbursement.
